Payment Options

Payment Plans

Payment plans are available to all patients regardless of financial status.

- For accounts under \$300.00 payoff within 6 months, starting from the month you receive your first bill
- For accounts over \$300.00 payoff within one year, starting from the month you receive your first bill

Account Balance	Minimum Payment
Under \$100.00	\$25.00 per month
\$101.00 – \$200.00	\$35.00 per month
\$201.00 – \$300.00	\$50.00 per month
\$301.00 and up	12 equal payments

Charitable Assistance Program (C.A.P.)

It is the policy of Santiam Memorial Hospital that those without the ability to pay will be fairly, consistently and objectively evaluated as to their eligibility for charity under stated guidelines.

- Charity Care is generally secondary to all other financial resources available to the patient including insurance, government programs, third party liability and liquid assets.
- In most cases, an application for the Oregon Health Plan (OHP) will be required. Documentation of acceptance or denial would then be provided with the application for charity care.
- The responsible party must return a completed application within the specified time. It will be made in writing and accompanied by sufficient documentation to verify income amounts indicated on the application form for the 12 months prior to the date of request.

Eligibility

- Responsible parties with gross family income at or below 150% of Federal Poverty Guidelines may be eligible for financial assistance at 100% of the amount due.
- Responsible parties with gross family income above 150% but below 300% of the Federal Poverty Guidelines may be eligible for a prorated amount of financial assistance
- Patients must apply for Medicaid and be found ineligible before they qualify for C.A.P.
